All shipments will be graded on an individual basis -there is no averaging of grades. Title will pass to MNSP upon delivery.

Ticket splits need to be given at the time of, or before delivery. Direct ship tickets will not be split between parties.

**Contracts Offered:** Cash, Basis, Futures Fixed, Price Later, Cash/Futures/Basis Offers, Deferred Payment

**Spot Policy:** Since 2007, Non-contracted grain deliveries and contract overruns are automatically priced on the closing bid of the of the first open market day following delivery.

**Futures Fixed/HTA Contracts:** Seller may elect to set **futures only** for a delivery period vs the respective futures month for that time frame (e.g. October delivery vs the NOV-X Futures). Contract can be rolled to a new delivery period and futures month one time within the crop year (at buyer's discretion) for a \$.02 fee. Market carry or inverse will be applied to the initial futures price when rolling. Basis must be set by the first day of the delivery period for which it is written or before first notice day of the respective futures contract, whichever is sooner. Initiation fees will apply and vary based on contract month.

**Basis Contracts:** Seller can set **basis only** for a delivery period vs the respective futures month for that time frame (e.g. October delivery vs the November-X Futures). Seller can set their futures price at any time before delivery, or may elect to deliver the beans and leave the futures price open. Pricing can be rolled to a new futures month one time within the crop year (at buyer's discretion) for a \$.02 fee. Market carry or inverse will be applied to the initial basis price when rolling. Contracts must be priced or rolled before first notice day of the respective futures contract. Seller relinquishes title to grain upon delivery and unpriced deliveries constitute a voluntary extension of credit.

**Price Later:** Any program and terms are offered at buyers discretion throughout the year. Price Later bushels must be spot sold and cannot be applied to future delivery contracts. If we are accepting Price Later, you must notify a merchandiser before delivery, or weighmaster upon delivery that you would like your grain put on Price Later or it will be spot sold. Seller relinquishes title to grain upon delivery and unpriced deliveries constitute a voluntary extension of credit. No quantity less than the full contents of a load will be placed on or priced off of a Price Later contract. Fall 25' Program Effective 09/15/25: \$.09/bu per month prorated daily (\$.003 per day) with no minimum charge. Any price later charges will be waived if grain is priced within 10 calendar days of delivery. Final price must be established by 10/15/26.

**Payment Terms/Deferred Payments:** Payments are automatically issued the first business day following contract completion. If you want to have your payment split, temporarily held, or deferred into next year please notify accountin before delivery. Grain must be paid out or placed on a deferred payment contract within 30 days of delivery per state regulations. No interest or premiums are paid on deferred payment contracts. Deferred payments will be automatically issued the first business day of the next year. We are transitioning all customer grain payments to ACH in 2025.
